Former Deputy Governor of People's Bank of China

Mr. Liu Mingkang was the first Chairman of the China Banking Regulatory Commission (CBRC) from 2003 to 2011, and was a member of the Monetary Policy Committee of the People's Bank of China. He was formerly Chairman and President of the Bank of China (2000-03), Chairman of China Everbright Group (1999-2000), Deputy Governor of the People's Bank of China (1998-99), and Deputy Governor of China Development Bank (1994-98).

Mr. Liu is a member of the 17th Central Committee of the Communist Party of China, and of the China National Energy Commission. He is also the Vice Chairman of the Committee for Economic Affairs of the National Committee of the Chinese People's Political Consultative Conference. From 1993-94, he was the Deputy Governor of Fujian province and Secretary-General of the Fujian Provincial Government.

He also serves as a senior fellow of the Hong Kong Institute of Bankers. He was a member of the Financial Stability Board (FSB), Vice Chairman of the Standing Committee on Supervisory and Regulatory Cooperation under the FSB, a member of the Governance Body of the Basel Committee on Banking Supervision, and a Director of the Board of the International Centre for Leadership in Finance and of Bank Negara Malaysia.

Mr. Liu sits on the International Advisory Boards of the Guanghua Management School of Peking University and the School of Economics and Management of Tsinghua University. He is the honorary Dean of the Lingnan (University) College of Sun Yat-sen University, in Guangzhou. The CBRC and Mr. Liu, personally, were jointly named Risk Manager of the Year 2009 by the Global Association of Risk Professionals. Mr. Liu has been an invited participant at the Aspen Institute, Group of Thirty, and many other important international economic and financial forums.

Since 2011, he has been a Professor and Chair of the Finance Department of the School of Economics, Peking University. He is also a visiting Research Fellow of Milken Institute in the US.

Frank specialises in financial economics and macroeconomics. He is author and co-author of four books, Measuring Risks of Deposit Institutions (Garland Publishing, 1994), Corporate Governance, Securities Market and Banking Reform (Peking University Press, 2003), Essays in Modern Economics Research (Shanghai People's Press), and Towards the Third Reserve Currency: RMB Internationalization (Peking University Press). He has also published more than 40 refereed articles in top economic and finance journals, such as the Journal of Financial Economics, Journal of Business, Economic Journal, and Journal of Development Economics. In addition, he has been published widely in Chinese academic journals such as Economic Research, China Social Science Journal, and Management World.

He has successfully completed several large research projects funded by RGC of the government of Hong Kong, HKU foundation, and HKU's China Business and Economics Strategic Research Theme. He has also received several grants from the business sector, such as from the Stock Exchange of Hong Kong and Shanghai Stock Exchange. His ongoing research projects include a project by the Hong Kong government on Hong Kong as an international financial centre and a project by China State Development Bank on capital-account liberalization in China.

Frank has also been committee member of the Government of Hong Kong, a member of advisory board on the Shenzhen Qianhai special economic zone and independent director for several companies in Hong Kong and China. He is a vicechairman of the China Finance Association in Hong Kong, and has been a consultant and advisor for several financial service companies. He has contributed to various media, including the New York Times, the Wall Street Journal, Times Magazine, People's Daily, Hong Kong Economic Journal, CNN and CNBC.
